3. Discuss and consider Adopting Budget for the Fiscal Year 2012-2013.
4. Discuss and consider adopting an ordinance establishing the Budget beginning October 1, 2012, and ending September 30, 2013, appropriating funds for the operation of the general fund, water fund, and sinking fund to pay interest and principal due on all city indebtedness.
5. Discuss and consider Adopting 2012 Tax Rate.
6. Discuss and consider adopting an ordinance levying ad valorem taxes for use and support of the Municipal Government of the City of Devine for the 2012-2013 Fiscal Year; providing for appointing each levy for specific purposes; and, providing when taxes shall become due when same shall become delinquent if not paid, with \$.4738 on each \$100.00 valuation of property for the maintenance and support of the general government (General Fund) and \$.0951 on each \$100.00 valuation of property for the Interest and Sinking Fund.
